<u>DPO – Direct Public Offering</u> - If a Direct Public Offering is agreed upon, Servants' Hill Bed and Breakfast will seek capital to add new properties and cash out investors. Each investor would have the choice of retaining some or all of their ownership. The exact amounts involved would have to be agreed upon at that time.

<u>Buy Out</u> - Statistics and studies show various hotel chains currently acquiring various types of existing properties at an increasing rate. The buy-out strategy for Servants' Hill Bed and Breakfast would be to sell its operations for \$40 million, where in each scenario, both the CEO of Servants' Hill Bed and Breakfast and the investors will be able to cash out and profit immeasurably.
